## RULES

1. Must be a Matagorda County resident. You must have been a resident for at least 180 days.
2. Must be female.  
**You must be able to show proof of residency. If you win and cannot show proof of residency you will lose your fees and/or winnings.**
3. Women's Professional Rodeo Association (WPRA) rules will be used.
4. It will be a 3-Division (3-D) format with whole second splits if there are 25 entries or less. If there are 26 or more entries, it will be a 4-D with half second splits.
5. Top 4 women will be eligible to compete again during Wednesday Slack Night. \$30.00 entry fee to be paid. **(CASH ONLY)**
6. You must be at least 14 years old or in High School or older.
7. Sixty-second time limits will be enforced.
8. Must be ready when name is called or you will be disqualified.
9. Absolutely no training in the arena. No circling the barrels.
10. Entry fees, if eligible for Wednesday Slack Night, must be paid immediately after results are announced. (A buckle will be presented to the winner of the Slack Night event.)
11. All contestants must run into a closed gate.
12. Enforcement of all rules will be by the committee. All decisions of the flagman are final. The committee will address any discrepancies. All decisions will be the final ruling of the committee.
13. Any inhumane treatment to horses and/or livestock will be grounds for ejection from the barrel race and/or fairgrounds with loss of entry fees.
14. PRCA Rules/Dress Code will be in effect during the Slack Night barrel race.
15. All participants must comply with the Matagorda County Fair & Livestock Association General Rules and Regulations. If still in High School, you **must** provide name of High School for eligibility.
16. **Coggins papers will be checked.**
