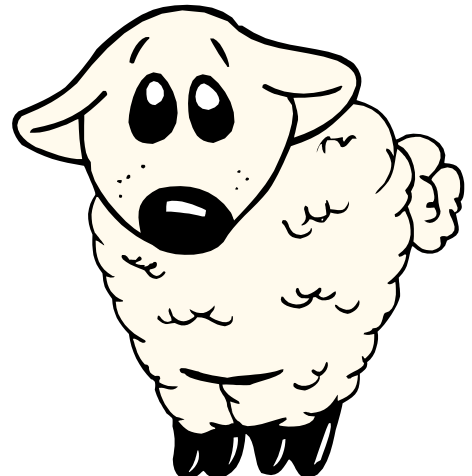
Dear Contestant & Parent/Guardian:

**CONTESTANT WAIVER AND RELEASE FORM**

The UNDERSIGNED hereby represent and warrant that they are the parent(s) or legal guardian(s) of the Minor CONTESTANT named above and that they have the full power, authority, capacity and right, without limitation, to execute, deliver and perform this Release.

**Request to Participant.** The UNDERSIGNED hereby request that the MINOR CONTESTANT be granted permission to enter the restricted areas and participate as a contestant in the MUTTON BUSTIN' competition (hereinafter referred to as "Event").

**Consideration.** In consideration of MINOR CONTESTANT being allowed to participate in the event, the UNDERSIGNED hereby agree to the terms of this Contestant Waiver and Release Form.

**Acknowledgment of Risk.** The UNDERSIGNED understand and acknowledge that rodeos and related livestock events are dangerous activities and that participation in a rodeo or related livestock event exposes the participant to a substantial and serious hazard which may result in property damage and/or personal injury or death. The UNDERSIGNED expressly acknowledge that the participation of the above named MINOR CONTESTANT will expose the MINOR CONTESTANT to such hazards.

**Release of Sponsor.** The UNDERSIGNED, being fully aware that participation by the above named MINOR CONTESTANT in the Event will expose the MINOR CONTESTANT to a substantial and serious risk of property damage and/or personal injury or death, hereby releases sponsors and the Matagorda County Fair & Livestock Association (hereinafter "RELEASEES"), from liability, and waives the right to sue, for any and all property damage and/or personal injuries or death, or other claims arising from the above named MINOR CONTESTANT'S participation in the Event, even if the property damage and/or personal injury or death is determined to have resulted from the negligent acts or omissions of the RELEASEES.

**Covenant Not to Sue.** The UNDERSIGNED covenant that they shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the RELEASEES, their officers, directors, employees, agents, assigns or affiliates for damages of any type arising from participation of the above named MINOR CONTESTANT in the Event, whether such claims be for the benefit of the UNDERSIGNED or of the MINOR CONTESTANT.

**Indemnification.** To the fullest extent permitted by law, the UNDERSIGNED hereby agree to defend and indemnify and to hold RELEASEE(S) harmless from any liability, claims, demands, causes of action, loss and/or damage arising from participation of the above named MINOR CONTESTANT in the Event, even if caused by the negligent acts or omissions of any of the RELEASEE(S).

Matagorda County Fair Association reserves the right to use any and all photographs taken during this event for our publicity.

We have read this Document; we understand it is a release of all claims. We appreciate and assume all risks inherent in this event.

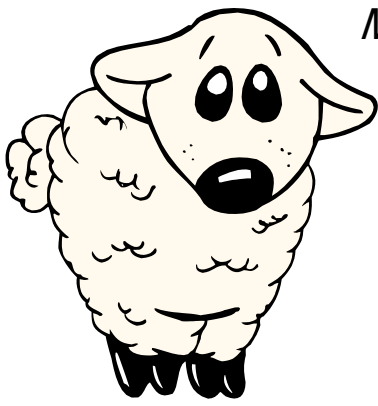

## **2018 MUTTON BUSTIN'**

### **RULES & INFORMATION SHEET**

- ❖ Entries will be accepted beginning, Wednesday, January 24<sup>th</sup> 2018 at 8:30 am at the Fair Office. We will accept the first 45 completed applicants only. Night preference (Thursday, Friday or Saturday) is accepted but not necessary guaranteed.
- ❖ Entry Form **will not** be accepted without (1) CONTESTANT WAIVER AND RELEASE FORM, (2) ENTRY FEE of \$25.00 and (3) a copy of BIRTH CERTIFICATE. (4) THE CONTESTANT CAN BE WEIGHED-IN BY THE SCHOOL NURSE OR DOCTOR'S OFFICE NO EARLIER THAN JANUARY 17, 2018, and must be on their letter head. **If your child is going too weighed by the School Nurse, PLEASE call ahead and give the nurse a few days' notice.** You can also bring your child to the Fair Office to be weighed.
- ❖ Entry fees are non-refundable!
- ❖ Your Mutton Buster will receive a gate pass for his ride night but you will have to purchase Rodeo Tickets. They may sit in your lap after their performance.
- ❖ No youth less than five (5) years of age or over eight (8) years age - nor over 55 pounds may participate. Proof of age (Birth Certificate) is required.
- ❖ You must report by **6:30 pm** to the **General Admission Area (Northwest Corner of Arena Barn)** for instructions on where the children will line up on night of ride. A Contestant Number will be issued at that time and must be worn during the entire event.
- ❖ Full face helmets are required and **will be supplied** by the Matagorda County Fair Association. Helmets are MANDATORY.
- ❖ Long sleeve shirts and pants are required.
- ❖ **ABSOLUTELY NO PARENTS ARE ALLOWED IN THE ARENA** during the Mutton Bustin' event. If you as a parent cannot conform to this rule, *please do not enter your child in this event.*
- ❖ NO RE-RIDES!
- ❖ No ropes or spurs.
- ❖ Contestant's guardian must sign contestant in when dropping them off to Mutton Bustin Chairperson and the contestant will NOT be permitted to leave until the guardian signs them out.
- ❖ After the event is finished, the Mutton Busters will be taken to the General Admission Area (northwest corner of the arena barn) to meet back up with their parents.
