**Request to Participant.** The UNDERSIGNED hereby request that the MINOR CONTESTANT be granted permission to enter the restricted areas and participate as a contestant in the MUTTON BUSTIN' competition (hereinafter referred to as "Event").

**Consideration.** In consideration of MINOR CONTESTANT being allowed to participate in the event, the UNDERSIGNED hereby agree to the terms of this Contestant Waiver and Release Form.

**Acknowledgment of Risk.** The UNDERSIGNED understand and acknowledge that rodeos and related livestock events are dangerous activities and that participation in a rodeo or related livestock event exposes the participant to a substantial and serious hazard which may result in property damage and/or personal injury or death. The UNDERSIGNED expressly acknowledge that the participation of the above-named MINOR CONTESTANT will expose the MINOR CONTESTANT to such hazards.

**Release of Sponsor.** The UNDERSIGNED, being fully aware that participation by the above named MINOR CONTESTANT in the Event will expose the MINOR CONTESTANT to a substantial and serious risk of property damage and/or personal injury or death, hereby releases sponsors and the Matagorda County Fair & Livestock Association (hereinafter "RELEASEES"), from liability, and waives the right to sue, for any and all property damage and/or personal injuries or death, or other claims arising from the above named MINOR CONTESTANT'S participation in the Event, even if the property damage and/or personal injury or death is determined to have resulted from the negligent acts or omissions of the RELEASEES.

**Covenant Not to Sue.** The UNDERSIGNED covenant that they shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the RELEASEES, their officers, directors, employees, agents, assigns or affiliates for damages of any type arising from participation of the above named MINOR CONTESTANT in the Event, whether such claims be for the benefit of the UNDERSIGNED or of the MINOR CONTESTANT.

**Indemnification.** Fully permitted by law, the UNDERSIGNED hereby agree to defend and indemnify and to hold RELEASEE(S) harmless from any liability, claims, demands, causes of action, loss and/or damage arising from participation of the above-named MINOR CONTESTANT in the Event, even if caused by the negligent acts or omissions of any of the RELEASEE(S).

## MUTTON BUSTIN'

### RULES & INFORMATION SHEET

1. Entries will be accepted beginning at 8:30 a.m. Monday, September 9, 2019 at the Fair Office.
2. Entries will not be accepted without (1) CONTESTANT WAIVER AND RELEASE FORM, (2) ENTRY FEE of \$25.00 and (3) a copy of BIRTH CERTIFICATE. (4) CONTESTANT'S WEIGHT.

**Weight verification must be on doctor's letterhead and must be dated after September 9, 2019. Entry forms without weight verification are considered incomplete and will not be accepted until contestants' weight has been verified. Please check with your school nurse to see if they will weigh your child, if so, weight verification must be on school letterhead. Your child may be weighed at the Fair Office at the time of application as well.**

3. The first 30 completed entries will be accepted and are non-refundable
4. No youth less than five (5) years of age or over eight (8) years, nor over 54 pounds may participate. Proof of age (Birth Certificate) is required.
5. You, **the parent of the Mutton Buster**, must sign your child in at the **General Admission Area in the Northwest Corner of the Arena** by **6:30 p.m. for instructions on where the children will line up**. A Contestant Number will be issued at that time and must be worn during the Mutton Bustin' event. **YOU MUST BE THE PARENT OF THE PARTICIPANT to sign him/her in and out after the event**. Your child will not be accepted as a participant or released to a brother/sister, aunt/uncle, or grandparent.
6. Full face helmets are now required and is MANDATORY. Matagorda County Fair Association will provide helmets to all riders.
7. Proper rodeo attire must be worn. Long sleeve shirts and pants are required.
8. **ABSOLUTELY NO PARENTS ARE ALLOWED IN THE ARENA** during Mutton Bustin'. If you as a parent cannot conform to this rule, *please do not enter your child in this event*.
9. **No** open toed shoes, Sleeveless or short sleeved shirts, ropes or spurs are accepted.
10. **NO RE-RIDES**.
11. There will be a first and second round with 15 contestants in each round. After the first round is completed, the Mutton Busters will be taken back to the General Admission Area to meet with their parents. The Mutton Buster with the highest score of the first go-round will need to stay with the second group until second round is completed to determine the overall winner.

#### AWARDS

The Mutton Buster that receives the highest score in the 1<sup>st</sup> and 2<sup>nd</sup> Go-round will be deemed the champion for that round and will receive a trophy. Of the two rounds, the Mutton Buster with the highest score will be named Overall Champion of the 2018 Bay City Bull Blast and will receive a buckle. **All other participants will receive a participation award.**
