The Talent Contest is a presentation of young people ages three through High School Senior. This contest is divided into four divisions with two categories in each division. Awards will be given to the winner from each category in each division. There will be an Award Presentation following the Talent Show.

- Senior** [ages fourteen (14) through nineteen (19)]

**REQUIREMENTS**

- 1. Solo contestants must be a citizen of the United States, a current resident of Matagorda County or attend home school, private school, or public school for the current year in Matagorda County. Contestants in groups must be a citizen of the United States, a current resident of Matagorda County or attend home school, private school, or public school for the current year in Matagorda County or have at least one member from Matagorda County and other members being residents in surrounding counties.
- 2. All entry forms must be accompanied by a birth certificate (photocopies only) or they will not be accepted.
- 3. Contestants shall be allowed to participate in no more than two performances limited to one solo and or one group.
- 4. The length of a performance will be no longer than four (4) minutes. Performances over four (4) minutes will have ten (10) points per minute deducted with a maximum of 20 points.
- 5. If props or musical instruments are needed, performer must provide them along with a drawn diagram of placement of props.
- 6. Any act needing musical accompaniment must provide a CD with only the song that will be performed. CD's must be in MP3 format, (must be able to play in a typical car or portable CD player). CD's must be on cue and labeled. **The CD should be turned in with Entry.**
- 7. A maximum of 4 microphones will be available for performances.
- 8. Elaborate setups which require more than 2 minutes setup time will not be allowed. This will allow the show to move along smoothly and minimize the total show time.
- 9. The age limit in groups consisting of various ages will be determined by the oldest member to classify them under the appropriate division.
- 10. All winners are asked to stay until the end of the show for pictures to be taken by the official Fair photographer.
- 11. The decision of the out of county judges will be final.
- 12. Entry fee for solo will be \$20 (twenty dollars) and group will be \$40 (forty dollars).
- 13. All protests concerning Matagorda County Fair Entries must be submitted prior to judging and be accompanied by a \$150 cash deposit. The deposit will be returned **ONLY** if the protest is upheld. Once judging has commenced **NO** protests will be accepted. The Judges decision is final and not subject for protest. Judging procedures will not be interrupted for protest investigation. The protest will be reviewed by at least (5) members of the Fair Board. The ruling of the Fair Board Directors will be final. Both sides of the protest must be present at the time of the protest. There will be no anonymous protests accepted. Every exhibitor, in consideration of his/her entry being accepted by the Matagorda County Fair and Livestock Association, agrees that the conclusion reached by the Fair Board Directors shall be final, without any recourse against the Matagorda County Fair and Livestock Association, Board of Directors, Division Chairman, Superintendent, or Committeemen.
