

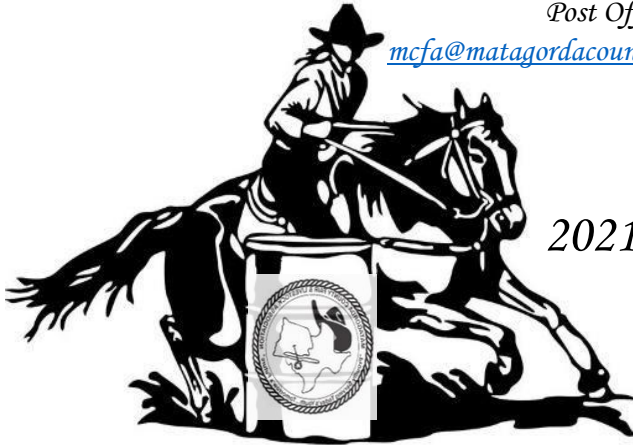

## 2021 Local Ladies Barrel Racing Rules

1. Must be a Matagorda County resident. You must have been a resident for at least 180 days.
  - **You must be able to show proof of residency. If you win and cannot show proof of residency you will lose your fees and/or winnings.**
2. Must be female.
3. Entry fee is \$40. And **must accompanied by the entry form. NO EXEPTIONS**
4. 3-D with half second splits. If 25 or more entries, it will be a 4D with half second splits.
5. Must be ready when your name is called, or you will be disqualified.
6. All contestants must run to a closed gate.
7. If timer fails contestant will receive a re-run
8. Women with the 4 fastest times are eligible to compete in Wednesday Slack Night. \$40.00 entry fee.  
**CASH ONLY!**
  - Entry fees, if eligible for Wednesday Slack Night, must be paid immediately after results are announced at the Local Ladies County Barrel Race.
  - Winner of Wednesday slack will receive a buckle. Buckle presentation will be held on Saturday night immediately following the Local Team Roping event.
  - Dress Code will be in effect during the Slack Night barrel race and buckle presentation. Boots, cowboy hat, and long sleeve shirt.
9. Exhibitions are \$5 each.
  - Each horse that is entered in the barrel race will be allowed up to two exhibitions before the barrel race.
  - After the barrel race is over, exhibitions will be open to anyone.
  - You are required to pay your exhibitions before taking them.
  - Exhibitions are NON-REFUNDABLE.
  - Exhibitions will have a 60 second time limit.
  - Money from exhibitions will be put into the pot for Slack Night. (\$1.00 of each run will be donated back to MCFLA)
10. Enforcement of all rules will be by the committee.
11. Any inhumane treatment to horses and/or livestock will be grounds for ejection from the barrel race and/or fairgrounds with loss of entry fees.
12. All participant must comply with the Matagorda County Fair & Livestock Association General Rules and Regulations.
13. All trailers are to park inside gate North of barn.
14. **All contestants must park in the parking lot south of the arena and enter gate Seven. Coggins papers will be checked before horses are allowed in the gate.**
